- Have no more than three (3) consecutive unexcused absences from Board of Directors meetings and/or activities.
- Represent all those whom this organization serves
- Actively participate on one major fundraising committee and attend and assist with others as you are able
- Declare conflicts of interest as it pertains to your position on the Board of Directors and abstain from voting when appropriate
- Do your best to ensure that the SSDF is growing and operating in the best interest of our Mission Statement.

If you are elected as a SSDF Board member, you may be required to obtain and submit records of a full criminal background check.
